## Informed Consent Agreement and Release of Liability for Parent/Guardian

This is an *Informed Consent Form* for parents/guardians which provides information relevant to students applying for early admission at Snow College.

Dear Parent/Guardian. Your student is being considered for early admission at Snow College. This is an exciting opportunity, but we want to ensure you understand some of what this means.

- **Eligibility** Early admission is conditional. Students admitted are only eligible to enroll in classes one semester at a time and will only be allowed to continue enrolling if they earn a semester grade point average of 2.00 or higher.
- **Registration** The student must register for Snow College credit through BadgerWeb by the established Academic Dates and Deadlines. They are also responsible for dropping or withdrawing from the course(s) in BadgerWeb or the appropriate web form by the established Academic Dates and Deadlines if they no longer wish to receive college credit.
- Classes Your student will take regular college classes designed for and attended by mature students, usually age 18 and above. These courses may contain material or subject matter of a more rigorous and mature nature. You may want to review a syllabus or speak with a professor before your child enrolls in a specific class.
- **Grades** The grade(s) earned through Early College will become a permanent part of the student's post-secondary record. Grades may affect the student's eligibility for future financial aid.
- Credits Credits earned through Early College will be applicable toward a degree at Snow College and are generally transferable to other colleges and universities. The student is responsible for ensuring the course(s) taken are transferable to their choice of college/university.
- **Policies** All policies affecting general Snow College students will apply. In addition, Snow College will not act in loco parentis to your child. You retain the duty to supervise and regulate their academic involvement and choices.
- Release of Student Records
  - Family Educational Rights and Privacy Act (FERPA) Snow College is required by law to keep student records confidential regardless of age. Without student permission, we cannot share student records with anyone but them (or appropriate Snow College officials, representatives, officers, employees, and agents). Please complete the optional Consent to Release Student Information form if your student would like you, as the parent(s) or legal guardian(s), to act on their behalf and have access to their student record at Snow College.

Early admission students who are not online-only and attend on campus are offered additional services, which include:

- Counseling and Wellness Center Your child will have access to all the services the campus Counseling and Wellness Center provides. This includes counseling.
- **Testing** This includes assessment, placement, and course testing services.
- **Library** The library is open to all students, and all materials are generally available without censorship. This includes materials intended for mature persons.
- Internet Access Your son or daughter will have access to the campus computer labs and the campus-wide Wi-Fi system. There are no filters on the internet services the College provides. Network users are expected to accept and abide by a technology user agreement.
- Campus Recreation Any activity, program, meetings, clubs, athletic events, etc. open to regular admit students are also available to on-campus, early admit students. This includes attending and participating in campus recreation on and off campus.
- **Campus Housing** Your student can apply for and receive campus housing. Assignments to rooms with similar-aged students will be attempted but not guaranteed.
- **Fitness Facilities** Full-time early admit students (12+ credits) can access all on-campus physical fitness facilities.
